

Pacific Crest Trail Association Wild Website Giveaway Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

You understand that you are providing your information to Pacific Crest Trail Association (the “Sponsor”), and not to Facebook, Instagram, Twitter. The information you provide will be used for the purpose of contacting winners and awarding prizes, as well as informing entrants about the mission of the Pacific Crest Trail Association. 1) Promotion Description: The Co-Sponsors are offering a variety of prizes to entrants (the “Promotion”) and will determine winners and award prizes via a random drawing. The Promotion begins March 30, 2015 and ends on March 31, 2015, (“Promotion Period”). The Promotion consists of two grand prize drawings.

2) Eligibility: The Promotion is open to legal residents of the fifty (50) United States and the District of Columbia and are eighteen (18) years of age and/or have reached the age of majority in their state of residence at time of registration. Employees, officers and directors of Sponsor, and their respective advertising, promotional, fulfillment and marketing agencies (collectively the “Promotion Entities”), their immediate families (parent, grandparent, child, sibling & spouse) and persons living in the same households as such individuals (whether related or not), are not eligible to participate in the Promotion. If you are a potential winner (“**Potential Winner**”), you will be contacted within two (2) business days at the e-mail address provided your Entry (“**Prize Notification email**”) and asked to certify that you are a resident of the fifty (50) United States and/or the District of Columbia and are eighteen (18) years of age and otherwise meet the eligibility requirements of the Promotion. Potential winner must reply via e-mail within two (2) days to claim their prize. Failure to comply with any of these provisions will result in disqualification and forfeiture of the prize. Failure to respond to the Prize Notification email within 48 hours will result in disqualification and forfeiture of the prize and the selection of a different Potential Winner.
